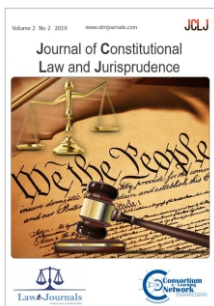

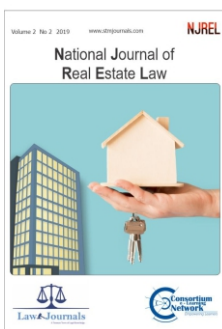

In addition, an attorney practicing real estate law may focus on a specific type of real estate law or a related area of law, such as oil and gas or natural resources law.

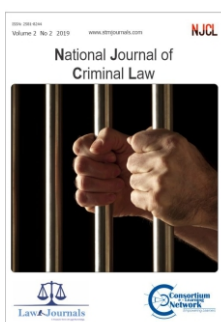
### Journal of Human Rights Law and Practice

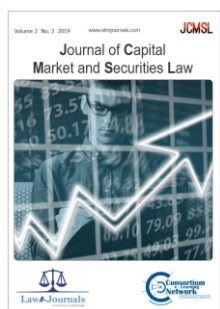
